Towamencin Township Reopens Improved Forty-Foot Road

Towamencin Township, Montgomery County, PA, January 17, 2007 - McMahon Associates, Inc., a full-service transportation engineering and planning firm with over 30 years of service, is proud of its contribution to the Grand Re-opening of the improved Forty Foot Road in the Towamencin Township, Montgomery County, Pennsylvania.
